Sub: To expedite Revision of Pension of BSNL Pensioners/Family Pensioners, who retired prior to 10.06.2013 by allowing the benefit of merger of 50% DA/DR with Basic Pay/Pension effectively amounting to 78.2% DA/DR to all the BSNL Pensioners of Gujarat Telecom Circle by the Post Offices.

We write to invite to communications issued by the competent authorities on the above subject as under:

1. DoT New Delhi No: 40-13/2013-Pen (T) dated 18.07.2016.
2. BSNL Corporate Office No: 40-6/2-11-Pen.(B)(Pt.) dated 26.07.2016.

The C.C.A. Gujarat implementing the captioned orders, have started to issue revised PPO for more than 10,000 Pensioners as the said orders envisaged the payment of revised Pension with arrears w.e.f. 10.6.2013 to till date on or before 31.12.2016 and completed its job for more than 90% ..

It has been brought to our notice by numerous pensioners that their revised PPO required to be forwarded to Pension Disbursing Authorities are inordinately delayed in the office of DAP.

As per information received by us hardly 10% Pensioners have got their Revised Pension but to get their Pension Arrear though the Head Post Offices have received the orders from DAP.

We appreciate the extra ordinary pressure created on the staff due to demonization issue but now is nearing to its end.

Since the last date for effecting the payment to Pensioners on Revised PPO is to be completed on or before 31.1.2016, we request you to kindly cause issuance of necessary detailed instructions to all SSPs/HPOs and Pension Disbursing Authorities, i.e. Post Offices.
