Respected Sir,

1. This is critical time, when country is passing through its testing time and all the citizens of the country, inclusive of our Associations is extending its heartiest support to Hon'ble appeal for 21 days lock down to overcome the crisis. In such time, one and all have to concentrate to one goal to assist all the persons within their jurisdiction and to help each other.
2. But, with agony with have to draw your kind attention towards the inhumane attitude of the Director, CGHS, Begaumpet, Hyderabad Office, as brought to our notice by the Circle Secretary, of our Association vide his letter dated 19.03.2020 which is self explanatory and needs no elaboration.

Sir, as per standing instructions of the Ministry of Communications, circulated by the Secretary, DoT, New Delhi duly endorsed by the BSNL Corporate Office, all the BSNL Retirees are entitled to receive their medical treatment under CGHS and have to go through the prescribed procedure. This procedure is equally applicable for VRS 2019 – VRS Optees as well.
4. Accordingly, the office of the CCA AP Circle and o/o CGMT have extended the help to the VRS 2019 Optees and accepted their surrendering their Medical Identity Card, confirming their Pay Scales from CCA AP and applied for CGHS Medical Identity Card enclosing all the required documents including the DD.
